1. Call Meeting to Order

Warden Nicole Albright called the meeting to order at 6:34 p.m.

2. Invitation to Stand and Move

Warden Nicole Albright reminded Council that they are permitted to stand and move as they need to during the meeting. This is an initiative by Argyle Recreation which normalizes movement in meetings.

3. Approval of Agenda

By consensus, the agenda was approved as amended with the addition of item 7. Councillor's Report.

4. Presentation – Siemens Canada – Electric Vehicles & Charging Stations

Deputy CAO Scott Surette was present via Zoom to give a brief history on why the study was done. A couple of years ago we were looking at replacing one of the Municipality's vehicles and going the EV route as there could potentially be some funding. Argyle received funding via the Low Carbon Community Fund to support a study around EV vehicles and forming a plan. Siemens was the successful contractor for the project. The goal of the study was to look at the current fleet and develop a plan to replace them as they come to their life expectancy, with also looking at what types of charging stations are needed within the Municipality.

Giles Counsell from Siemens joined Council via Zoom to give a presentation on EV and Charging Stations. He presented the electric vehicle replacement options for over a 10-year period, as the current vehicles reach their life expectancy. The total cost for vehicles and chargers is around \$389,771.

Councillors had questions regarding the EV vehicles, their life expectancy, their resale value, and the ways they can charge.

Some cons that were raised were the flicker, the look of the windmills and the noise. This is a big project and has been delayed by a year. There was an ongoing project that wasn't complete, and the company wanted to complete that project before starting this project. The roads and foundations are set to be completed this summer, and windmills should be starting to be installed by Spring of 2026.




