1. Call Meeting to Order

Warden Nicole Albright called the meeting to order at 6:32 p.m.

2. Invitation to Stand and Move

Warden Nicole Albright reminded Council that they are permitted to stand and move as they need to during the meeting. This is an initiative by Argyle Recreation which normalizes movement in meetings.

3. Approval of Agenda and Conflict of Interest Declaration

It is MOVED by Councillor Darryl LeBlanc and SECONDED by Councillor Malcolm Madden to approve the agenda with the addition of items 12C Butte de la Croix and 12D Le Club des Acadien de Seniors de Wedgeport.

MOTION CARRIED UNANIMOUSLY

Councillor Boudreau declared a conflict of interest for the Wedgeport Heritage Society Community Grant. He will excuse himself from the meeting during that time.

Councillor Madden has declared a conflict for 3 of his grant requests and will excuse himself from that part of the meeting.

Councillor Bourque declared a conflict of interest for the East Side Community Centre Grant.

4. Presentation – Free Store Presentation from Evangel Assembly

Reverend Cindy Dunnett, Care and Connection Pastor at Evangel Assembly, spoke about the church's Free Store, which was launched in December 2022 to address food insecurity identified during the COVID-19 pandemic. The program initially started with grocery box distribution, the initiative evolved into a more sustainable model offering free groceries, clothing, and household items at the former Lighthouse Church on Argyle Street.

The store operates monthly on the second Wednesday and has seen consistent growth, now serving people from Yarmouth town, the municipality of Yarmouth, and the municipality of Argyle. The store is staffed primarily by senior volunteers and operates with dignity and confidentiality for clients.

In the most recent month, the store filled 62 requests, serving 160 people (74% adults, 26% children). Year-to-date, 291 requests have supported 807 individuals. About 30% of these are single-adult households. The cost per request averages \$35.

The purpose of the presentation was to raise awareness to the program.

5. Approval of Minutes

a. April 24, 2025 – Executive Council Meeting Minutes

By consensus, the April 24, 2025, Executive Council Meeting Minutes were approved with the change of “West Pubnico Fire Department for year 2 of 2 at 0.09 cents per \$100 of assessment for the fiscal year 2025-2026”.

6. Recognizing Argyle – Council Announcements

Councillor Diggdon wished a Happy 97th birthday to a resident in his district and he thanked the volunteers from various organizations that have been picking up litter around the communities.

Deputy Warden Ted Saulnier thanked the Ground Search and Rescue that came from all over South West NS to search for evidence in the disappearance of Zach LeFave which took place over two days.

Warden Albright reported on presenting to students in grades 3-5 at the Plymouth School about what a councillor does. She mentioned the students were very interested and engaged.

7. Warden’s Report

The Warden’s Report was attached to the agenda, there were no questions on the report.

8. Committee Reports

Councillor Bourque reported on a new reuse centre that will be opening at the waste park, where items that are still usable but discarded can be resold by non-profit organizations who will then be able to keep the profits to support their organizations.

Councillor LeBlanc reported on the Yarmouth Airport Task Force being active with several new members. Plans are underway for a joint meeting involving all three municipal councils and local MLAs to provide a full update on recent developments and the future direction of the airport.

Councillor LeBlanc also reported on the hiring process for the new aquatics manager at the Mariners Centre. After a thorough interview and scoring process involving multiple strong candidates, a selection has been made, and an announcement will be made in the near future.



9. 7-day Notice

a. Article C57 – Veterans Banner Policy

Council received 7-day notice on the NEW Article C57 – Veterans Banner Policy.

10. For Decision and Discussion

a. Budget Presentation - Operating Fund & Capital Fund

CAO Muise went over the operating fund and highlighted the major expenditures that were garbage and policing. He highlighted the difference between mandatory and optional expenses. The operating budget is up for approval this evening, however the capital fund will be up for approval next week.

It is MOVED by Councillor Darryl LeBlanc and SECONDED by Councillor Kathy Bourque to approve the Operating Budget for the fiscal year 2025-2026 as presented.

b. Tax Rate Approvals - Residential, Commercial and Resource

It is MOVED by Councillor Darryl LeBlanc and SECONDED by Councillor Malcolm Madden that Council approve the following rates for the 2025-2026 fiscal year: Residential \$1.13 per \$100 of assessment (increase of 2 cents), Resource \$1.13 per \$100 of assessment (increase of 2 cents), Commercial \$2.29 per \$100 of assessment (no change).

c. Temporary Borrowing from Operating Reserve

It is MOVED by Councillor Glenn Diggdon and SECONDED by Councillor Kathy Bourque to authorize a temporary loan of up to \$2,000,000 (non-interest bearing) from the operating reserve to the operating fund with full repayment by August 31, 2025.

d. Youth Wellbeing Network - Request for Committee Member - Deferred from last meeting

It is MOVED by Councillor Darryl LeBlanc and SECONDED by Councillor Greg Foster to appoint Deputy Warden Saulnier to the Youth Wellbeing Network Committee.

e. Physician Recruitment Committee - Request for Alternate - Warden Albright

It is MOVED by Councillor Darryl LeBlanc and SECONDED by Councillor Glenn Diggdon to appoint Kathy Bourque as the alternate for the Physician Recruitment Committee.

MOTION CARRIED UNANIMOUSLY

Councillor Greg Foster raised an issue concerning poor landline service from Bell Canada in the Hubbards Point area. A resident experienced days without phone service, yet a 911 call somehow registered, prompting an RCMP visit. Although Bell replaced the cable from her home to the main road, others in the area continue to suffer from issues like crackling and snapping on the line. The root cause appears to be outdated infrastructure, with new cables installed in some regions (e.g., Tusket and Morris Island), but not in the affected in-between areas.

Cell phone service is also unreliable; an example was given where a call between two people just 2 km apart was impossible without switching to landlines.

Councillor Foster criticized poor customer service and the lack of accountability. He highlighted the Commission for Complaints for Telecom-television Services (CCTS), a free ombudsman service that helps resolve telecom disputes. However, few Canadians (only 20%) are aware of it, and telecom companies often fail to inform customers as required by law.

CAO Muise indicated the provincial government is aware of and shares concerns about poor cell phone coverage in the area. Plans are underway to construct or upgrade cell towers, with some activity expected as early as spring this year. Key areas targeted include East Kemptville, Port Maitland, North Range, Middle Ohio, Corberie, Carleton, and Port Maitland—though not all are immediately local.

Some communities, like Quinan and East Kemptville, currently have no cell service at all, making the issue especially urgent. While it's uncertain how much the new infrastructure will improve service, there is hope that it will help.

It is MOVED by Councillor Greg Foster and SECONDED by Councillor Glenn Diggdon to write letters to telephone companies and regulators as well as federal and provincial government partners in order to lobby for better telephone service in the Municipality of Argyle.

g. Updates - Councillor Malcolm Madden

Councillor Madden submitted a request for an update on the flooding on Highway 3 and Highway 308. Executive Assistant Newell provided an update for Council that the Municipality and Province are collaborating and are still investigating what the issue may be, as they ruled out the Canada Post property as being the issue. During the next big rainfall, Director of Operational Services, Kyle Boudreau, along with the province, will go back to the site to investigate other causes.

Councillor Madden also requested an update on correspondence to the province that was requested by a council motion. CAO Muise provided an update indicating a phone call was made shortly after the motion passed to inform provincial officials, including Bruce Hancock and the Deputy Minister, of the council's request. The province has acknowledged receipt of the motion but has not yet responded.

A separate discussion was held regarding when a motion is necessary to communicate with other government officials. It was concluded that if Council is making a formal request for action from the

province, a motion is required. However, if the communication is solely to share information, a motion is generally not needed.

h. Approval of List of Charitable Organization Tax Exemption

Councillor Diggdon declared a conflict of interest for this item and refrained from voting on it.

It is MOVED by Councillor Ted Saulnier and SECONDED by Councillor Greg Foster to approve the list of Charitable Organization Tax Exemption as presented.

i. Interest on Overdue Accounts

It is MOVED by Councillor Kathy Bourque and SECONDED by Councillor Racheal Surette that Council approved the interest rate of 13% per annum on overdue accounts and that the current year's property taxes be payable and due by July 31, 2025, and interest will accrue after that date.

14. Question Period

CAO Muise answered various questions from the public that were received from Facebook.

Q: What percentage of the tax collected is being spent in the town of Yarmouth and the municipality of Yarmouth?

A: The regional investment is 7.2% of total taxation.

Q: Was there consideration given to increase commercial rate, and what were reasons not to do so to help offset the increase in expenses?

A: The commercial rate was unchanged for a number of reasons. 1. The rate of 2.29\$ was compared to other regions for consistency and we found the rate to be less competitive than the residential rate. Second, the commercial taxpayers were not protected by any cap on assessment. They experienced a decrease in assessment this year, thankfully, but not before seeing increases in the past two years of about 20% total. It was concluded that because of those increases, with no protection, that the rate should remain unchanged.

Q: Regarding the Mariners Centre expansion, is the issue of the proposed single-user bathroom and change area still under discussion? Will there be an opportunity for public input on this matter, and what is Council's current position on the issue? Thank you for your time and consideration.

A: The decision, along with all Mariner Centre expansion matters, was delegated to the Mariners Centre Expansion Board (MCEB), not this council.

An architect was engaged, and approximately 20 public engagement sessions were held in various communities, including Pubnico and the Municipality of the District of Yarmouth. These sessions, led by then-CEO Dorgam Hideib with Iris Communications, included significant discussion around universal change rooms, which raised both concerns and support.

The decision to proceed with the universal washroom design was made in December 2023, and construction is already underway, so further public consultation on the structure is no longer feasible. However, operational aspects of the facility can still be discussed going forward.

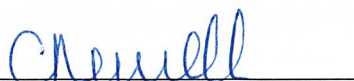
