1. **Call Meeting to Order**

Warden Nicole Albright called the meeting to order at 6:30 p.m.

2. **Invitation to Stand and Move**

Warden Nicole Albright reminded Council that they are permitted to stand and move as they need to during the meeting. This is an initiative by Argyle Recreation which normalizes movement in meetings.

3. **Approval of Agenda and Conflict of Interest Declaration**

Councillor Greg Foster requested to add update on flooding on Highway 3 and 308.

Warden Nicole Albright declared a conflict of interest on item 11A – First Reading of Development Agreement for Deons Oyster Company.

4. **Presentation**

4.a **Mersey Tobeatic Research Institute**

Sarah Clements from the Mersey Tobeatic Research Institute (MTRI) provided an overview of bat conservation in Nova Scotia. MTRI is a non-profit environmental organization based in southwestern Nova Scotia that focuses on biodiversity conservation and species at risk through research, collaboration, and community science. Sarah explained that Nova Scotia is home to six bat species, all of which are endangered, and highlighted the ecological and economic importance of bats as primary consumers of night-flying insects and as pollinators. She addressed common myths about bats and emphasized that they are not dangerous, have good vision, and pose a very low rabies risk. The presentation outlined major threats to bat populations, particularly white-nose syndrome, an invasive fungal disease that has caused severe population declines since its discovery in 2006 and remains an ongoing issue. Additional threats include habitat loss, pesticides, wind turbines, climate change, and human disturbance. Sarah encouraged community involvement through reporting bat sightings via batconservation.ca, installing bat boxes, creating bat-friendly habitats, keeping cats indoors at dusk and dawn, and spreading accurate information about bats. She also shared local data, noting limited bat reporting and known roosts in Yarmouth County, and

challenged residents to help improve knowledge and conservation efforts in the region.

Councillor Boudreau thanked the volunteers responsible for the lobster trap tree and the gazebo Christmas tree for their efforts and contributions.

11. For Decision and Discussion

11.a First Reading - Development Agreement - Deons Oyster Company

Warden Nicole Albright declared a conflict of interest and left the room at 6:57 p.m. and Deputy Warden Ted Saulnier took the position of the chair.

Erin Sauve of WSP presented a development agreement application from Deons Oyster Company to permit marine-related aquaculture use on a property along Highway 3 in Eelbrook. The application seeks to bring long-standing aquaculture operations, in place since 1995, into compliance with the current Municipal Planning Strategy (MPS) and Land Use Bylaw. While the property was previously zoned to allow such uses as-of-right, aquaculture uses within the current Coastal Community zone now require a development agreement. The 2.3-acre property includes shipping containers and a sorting and grading building, with access currently provided through an adjacent property under the same ownership; driveway access and lake-related activities are regulated provincially. Staff indicated the proposal aligns with the intent of the Coastal Community designation and is enabled under MPS Policy 3.37. Public engagement will follow the Municipal Government Act, including a required public hearing, newspaper advertisement, on-site signage, mailed notices to nearby properties, and an appeal process. The application is currently at first reading, with the next steps being a public hearing and subsequent council decision.

Councillor Foster raised concerns about recurring flooding at Highway 3 and 308 near Carls Store, noting past incidents where water washed across the roads and parking lot, creating icy hazards for vehicles. He asked for an update on the situation. CAO Muise responded that the Department of Public Works has not yet provided an update, but the Operations Department is following up urgently. Due to dry conditions over the summer, it was difficult to determine the water source, but recent rainfall should allow further assessment.

A member of the public asked why an amendment to the Land Use Bylaw (LUB) is required for the Deons Oyster operation, given that it is already in place. Director of Protection Services, René Jeddry explained that the existing operation is considered a non-conforming use under the current LUB, which allows it to continue as is but prevents expansion or new buildings. To pursue any expansion or additional structures, the operator must apply for a development agreement.


