Tender packages for the purchase of one Municipal half ton Truck were opened on Thursday February 20, 2020 at 2:30pm. In attendance: Guy Surette (Deputy Warden), Tara Owen (Recorder) and Hans Pfeil (Director of Public Works).

Three tenders were received, including 4 individual offers

The tenders were evaluated based on the following criteria:

- 1. Purchase Price
- Used Vehicle Age / Mileage
- 3. Fuel economy
- 4. Warranty offer

Based on the submitted tenders we would like to highlight that one vehicle was offered as "New" and in consultation with our solicitor we determined that the new vehicle is outside the requested submission requirements and not acceptable as a valid offer.
