Honourable Minister Jordan,

Recent escalation of tensions surrounding lobster fishing in South West Nova has brought us to a point where our silence is no longer an option. We, as Council for the Municipality of the District of Argyle recognize that the rules and regulations surrounding the lobster industry are in the hands of Provincial and Federal Governments, and rarely delve into its complexity, but our fishermen need our voice. The industry needs our voice, and the future of the lobster industry need our voice.

It is abundantly clear that current and previous governments failed in their responsibility to clarify First Nation's legitimate rights to fish and the balance that must be implemented to secure a sustainable lobster fishing industry for <u>all</u> parties.

The Municipality recognizes the value of the Marshall decision, and is aware of the important efforts to continue working alongside our First Nation people to recognize the value and validity of Treaty Rights. Most of our fishermen in this Municipality recognize that. This is not the issue.

The issue is that there is an ongoing <u>commercial</u> lobster fishing <u>industry</u>, occurring outside the established lobster season, with little to no accountability. Preservation of this species is of utmost importance.

The lobster industry in Argyle is the backbone of our local economy, and it is the responsibility of the Federal and Provincial Government to take this issue head on; and hold anyone accountable for the ongoing commercial fishing occurring outside of our season, and endangering the long term durability of this important economic driver. We are imploring you and your government to make every effort to deescalate the current situation and bring appropriate people to the table for conversation.

Both the First Nation and non-indigenous fishers in South West Nova deserve clarity. Please, establish some form of regulatory framework that enables appropriate food, social and ceremonial fishing for our First Nation people, and rules that prohibit the commercialization of that fishing outside of the season! As you are no doubt aware, this is a sensitive time of year to be catching lobster. This is why our fishermen are so upset.
