**Presentation-MLA Colton LeBlanc**

MLA Colton LeBlanc talked about Public Works issues that Council had. He stated the best way to get things addressed by the Department of Public Works is the report them to the 1-800 number or the email address and report the issues. The ticket number you receive is a great way to be able to follow up with them if they do not respond to the issue.

MLA Colton LeBlanc addressed the Mariners Centre Expansion. He indicated that the funding stream is significantly different from what they typically see. The province is waiting for guidance from Infrastructure Canada, as it is a Federal Government funding program. He indicated that Deputy Warden may want to check back in with the Department.

Honourable Colton LeBlanc addressed various other issues with Council and expressed his thanks to Council. He told Council to reach out whenever they have issues or concerns.

Councillor Boudreau: Attended regular meetings and visited residents regarding the flood issue.

Councillor D'Entremont: Attended YASTA Meeting, he indicated the CAT schedule is out and will be starting on May 19<sup>th</sup>. In June, TMAC will be visiting our area. They are partnering with local establishments like the CAT and the Fundy Rose. He indicated that he spoke to one of the owners of Inshore Fisheries to see if the Speed Radar sign had helped in the area of concern on the Dennis Point Wharf Road. It has slowed down a little bit. There was also a letter written to the Municipality regarding the Fibre Op Internet by Inshore Fisheries owner to see if there was any way they could be higher priority on the list since they do business on that road and it is difficult to conduct a business with slower internet. Councillor d'Entremont indicated that this letter had been handled by Deputy CAO, Scott Surette and wanted to thank him for his attention to this matter.

Councillor Diggon: Attended regular meetings, he stated he is finding it hard without the human interaction that the COVID Outbreak is restricting. He is also putting a team in to the Coldest Night of the Year fundraiser to help support
