# MUNICIPALITY OF THE DISTRICT OF ARGYLE REGULAR COUNCIL MEETING

Tuesday, October 11, 2022 Council Chambers, Tusket, NS 6:30 p.m.

## 1. Call Meeting to Order

The meeting was called to order at 6:31 p.m. by Warden Danny Muise.

## 2. Approval of Agenda/Conflict of Interest Declaration

a. Agenda

On a motion by Councillor Glenn Diggdon and seconded by Deputy Warden Nicole Albright the agenda is approved as circulated.

Motion Carried. (8 in favour, 0 against)

#### b. Conflict of Interest Declaration

Warden Danny Muise asked for any declarations of conflict of interest from the floor. None declared.

## 3. Presentation - Natalie d'Entremont - AT Plan

Natalie d'Entremont, Director of Recreation Services is presenting the Active Transportation plan. The Municipality hired WSP to revise the existing 2016 Active Transportation Plan. Natalie indicated that they held workshops, open houses, and online surveys. She mentioned the open house that was held at Plymouth was well attended, with a letter of support for some of the infrastructure from that group of people. There were over 200 people engaged for the public engagement piece involving the survey given out.

Natalie is presenting changes for council to consider. For the 0-5 year plan, they are recommending signage be installed on trails, developing marketing materials to promote active transportation opportunities in Argyle, investigate the opportunity to have an all-day posted speed limit sign of 50 km/h in the Plymouth School District, Investigate the opportunity of reducing the posted speed limit along Argyle Sound Road and along Trunk 3 from Argyle Head Road to Argyle Sound Road, invest in new paddling infrastructure and promoting it, work with NSPW on the 103 Highway Argyle Interchange Project (Glenwood, Drumlin exit), conduct a pilot project to provide a complete sidewalk connection between Chemin de l'eglise and Eglise paroissale catholique Saint-Pierre, create a functional plan for an AT connection along Route 334 between Plymouth School and Newell Road, create a plan for an AT connection along Route 308

between ESPB and the Argyle Township Court House & Gaol, create a functional plan for the extension of the ashphalt sidewalk ending at Abbotts Harbour road to Ecole Pubnico-Ouest.

Long Term Projects include preparing a detailed design for the Chemin de l'eglise project, the Plumouth School and Newell Road project, the ESPB and Argyle Court House project, the sidewalk in West Pubnico and Ecole Pubnico Ouest Project, prepared a detailed design to provide a more direct connection at the rail trail for DHCS students and staff.

Some ongoing projects are to continue building and installing furniture for AT users, host regular AT event, resurface the Rail Trail in East Pubnico, Resurface the rail trail from Tusket to the Western Municipal Boarder, place bike racks at important civic addresses.

Natalie identified the sources of funding that is available for Active Transportation.

Natalie is looking for Council to pass this presentation, which is on the agenda for decision later on.

a. Correspondence to Premier Houston

A letter was sent to Premier Houston regarding negative comments in the media about the CAT Ferry, signed by the Warden.

#### 6. Councillor Reports

Deputy Warden Nicole Albright reported on her attendance of the following meetings: Elemental Energy, Audit Committee, and Doctor Recruitment, where she mentioned there are still deficits in Doctor's in our area. The committee is still working on recruitment and retention, and getting feedback from doctors that have stayed here about what is working and what is not. She also reported on her attendance of the Mariners Centre Expansion Steering Committee meeting where they talked about upcoming budget and what may be needed. She mentioned a request will be coming to council for funding. They agreed to hire a firm for governance, and are recruiting for fundraising chair person. Deputy Warden also wanted to report that Halloween on the Trail for Recreation will be happening at the Trail in Belleville at 6 p.m. on October 26, 2022.

Councillor Kathy Bourque reported on her attendance at the Western County Regional Library, Audit Committee meeting, and Nakile meeting. She mentioned there are now 2 community signs up, one in Lower East Pubnico, and one in Pubnico Head going to East Pubnico. She thanked everyone for their support. She also reported on a little boy diagnosed with leukemia in her

district, and that the community has raised over \$30,000 by fundraising for the family. Councillor Bourque mentioned one more fundraiser at the Hipson Bridge on Saturday.

Councillor Guy Surette reported on his attendance at the Yarmouth Area Industrial Commission Meeting, and the Mariners Centre Expansion Steering Committee. He mentioned that after talking to Don Houston, he called about potholes on the Chemin de Bouleaux, they were fixed and within 2 days they were holes again. Councillor Surette brought up an in-camera item to be discussed at a later time.

Councillor Gordon Boudreau reported on similar meetings attended, such as the Nakile meeting, the Department of Transportation meeting, and a Personnel meeting for Nakile. He also reported on his attendance for two potential wind farm projects. He indicated he is working with our Deputy CAO and residents to look at getting funding for new bleachers for the ball field in Wedgeport.

Councillor Calvin d'Entremont reported for YASTA. He mentioned that yesterday was the last passing for the CAT, and there were around 40,000 passengers for the first year back after three years, which he considers to be a success. He reported on cruise ships that arrived in Shelburne, that brought some tourists to our area.

Councillor Glenn Diggdon said a Thank you to Jill and Todd Brannen going around on behalf of Love Atlantic with churches, giving out thank you cards to people in the community.

Councillor Ted Saulnier reported it was quiet in his district at the moment, but there is a lot of buzz about the windmills in community with the different presentations.
