As described in our email conversation please accept this as our official request.

Wanted to pass along the good news the we have been successful with our application for a generator from the province.

"I am pleased to tell you that your recent application for funding under the Community Generator Program has been approved. The Department of Communities, Culture, Tourism and Heritage will invest \$17,929 towards your generator project for the 2022- 2023 fiscal year."

When I submitted the application the quote from Irving Propane was not in yet so I put in a \$5,000.00 place-holder in the application. When Irving finally came they advised me that the place where we had planned to install the generator was not acceptable. The new place is in front of the old hall where the electrical mast is located. This meant that more has to be spent on the trench for the fuel line as it now is farther away from where the four 400 litre cylinders are to be placed and also we need to put at least five to six bollards in front of the 24Kw generator to protect it from vehicles. These new unforseen expenditures (approximately \$2,500.00) will have to be absorbed by us as the project is an 80% / 20% split. We have indicated to the province that we were prepared to allocate \$4,482.21 as our share. I do realise that our community centre has recently be given \$10,000.00 for our floors and I was not going to request any further funds from the municipality as we had had our fair share. However, with these new expenditures and the fact that we are now a Comfort Centre, I would hope that you agree with me that the proper installation of this generator is a priority for our community and municipality. Therefore I am requesting that the municipality grant us \$2,500.00 to pay for the unforseen expenses for the proper installation of our generator.
